



PUBLIC NOTICE
TO INTERESTED PERSONS HAVING THE RIGHT TO SIGN AN APPLICATION
TO PARTICIPATE IN A REFERENDUM CONCERNING A DRAFT 596-19
MODIFYING ZONING BYLAW 596

PUBLIC NOTICE is hereby given:

At a sitting of Council held on October 7, 2024, the municipal council of Town of Brome Lake adopted the **Second Draft Project of Bylaw 596-19** Modifying Zoning Bylaw 596

The Second Draft Project concerns a change to add the following land use category in Zone UMV-3-H12:

C32 Establishment where personal services are offered:

Only establishments providing the personal services of barbers, hairdressers, aestheticians, milliners, laundry, dry cleaner without solvents, taxi dispatcher, tailors, shoemakers, and photographers

This Second Draft Project contains 1 provision in respect of which “Interested Persons” in the zones described below may make an Application to Participate in a Referendum in compliance with the *Act Respecting Elections and Referendums in Municipalities*:

- i) Add the land use category C32 (as described above) in Zone UMV-3-H12.

DESCRIPTION OF TARGET AND CONTIGUOUS ZONES

Interested Persons of the following zones may make an Application to Participate in a Referendum asking that the Second Draft Project of bylaw 596-19 be subject to the approval by Qualified Voters in a referendum. The **target zone is UMV-3-H12** (located at and near the intersection of Bondville, Frizzle, and Mill roads in Bondville). The **contiguous zones are AFB-1-H11, RB-2-H11, UE-1-H12, UV-4-I12, UV-5-I12 and UV-1-H11**, as identified in the map at the bottom of this Notice. The target and contiguous zones include the following streets: Saint-Andrew, Rosedale, Papineau (including civic numbers 3 to 36), Alarie, Loiselle, Bondville Road (including civic numbers 370 to 500), Saint-Jude (north side only), Lionel, Roberge (including civic numbers 55 to 61), Cowell, Gaudord, Prouty, Beach Hill, Godefroy, Beauregard, Ouimet, Frizzle (including civic numbers 212 to 236).

INTERESTED PERSONS

An Interested Person is anyone not subject to a voting disqualification and who meets the following conditions **on October 7, 2024**:

- i) Be domiciled in a target zone or contiguous zone from which a valid Application can be submitted and be residing in Québec for a minimum of six (6) months. Be of full age, of Canadian citizenship and not be under curatorship;

OR

- ii) Be, during the previous twelve (12) months the owner of an immovable (not your primary residence) or occupant of a business establishment according to *An Act*

Respecting Municipal Taxation, in a target zone or contiguous zone from where an application may be submitted.

Additional conditions for undivided co-owners of a building or co-occupants of a business establishment:

Be designated, by means of a power of attorney signed by the majority of the co-owners or co-occupants, as being the person having the right to sign the application in their name and be entered on the referendum list, when applicable.

Condition for the exercise of the right to sign an application by a moral person: every moral person must designate among its members, directors and employees, by resolution, a person who, on October 7, 2022, is of full age and is a Canadian citizen, is not under curatorship and is not subject to any inability to vote under the Law. This designated person may submit an Application on behalf of the moral person.

Except in the case of a person designated as the representative of a moral person, no person may be considered as an Interested Person in more than one capacity in accordance with section 531 of *An Act Respecting Elections and Referendums in Municipalities*.

CONSULTATION AND MAKING A VALID APPLICATION

The Second Draft Project of Bylaw 596-19 may be consulted and the **Application** can be made using the *Application for the Holding of a Referendum* form available at Town Hall, 122 Lakeside Road, (from 8 a.m. until 4 p.m. Monday to Thursday, and from 8 a.m. until noon on Fridays), or on the Town of Brome Lake website: lacbrome.ca/municipal-life/public-notices. The Application must:

- iii) Clearly indicate the address and zone from which it originates;
- iv) Be signed by at least 12 Interested Persons (in individual Applications or in a single group Application) in a zone with more than 21 Interested Persons, or by the majority of Interested Persons in a zone with fewer than 21 Interested Persons.

The period to receive Applications begins October 16, 2024. **Applications must be received by latest October 28, 2024, at 4 pm**, either by e-mail to the Town Clerk (greffe@lacbrome.ca), by fax (450-243-5300), in person at the Town Hall, (122 Lakeside Road) or by mail (122 Lakeside Road, Lac-Brome, Québec, J0E-1V0). People using the mail are invited to send the Application as soon as possible and to take into account possible delays in mail delivery.

ABSENCE OF AN APPLICATION


